

Analytical Report on Parent's Feedback

Parents have delivered the future of their children into the institute's hand, for that reason, they play a very central role in the development and enhancement of the quality of this learning experience. Parent's feedback allows the organization to evaluate its service providing and thus furnish in delivering excellent service towards the scholars. Statistical report based on parent's feedback concerning to various standards has been discussed below.

I. CURRICULUM DESIGN & DEVELOPMENT

Program design refers to the ways in which we advert out the curriculum components. Curriculum designs attempts to address curriculum components. The present enquiry attempts to investigate the outfit of curriculum design and development based on the listed criteria.

From the review results represented in the table below, it is obvious that sixty six per cent, (out of 200 respondents) showed their high satisfaction level regarding the relevance of their wards programme, however three per cent among the total respondents marked their opinion as excellent. Queries based on wards satisfaction based on syllabus prove to be really nice for sixty seven per cent (134 respondents).

Reponses based on opinion on the semester system also proves excellent for one per cent among parents and 130 of them opined their high satisfaction; however fourteen per cent of them only showed their approval level as averagely satisfied. Considering the rating regarding internal evaluation of their ward proves to be highly satisfied for seventy-three per cent of respondents, whereas two per cent sensed to be outstanding.



II. GENERAL ASPECTS

Criteria based on general aspects includes, discipline within, teacherstudent relationship, level of individual attention given to students, approach of administrative staff, transparency in governance, wards exposure to adequate learning resources, wards overall performance, effectiveness of Parent Teachers Association & Parent Teacher Student get-togethers, Survey based on the above-mentioned norms had been conducted and reported here with,

Majority of the parents (89 per cent of respondents) showed their high satisfaction regards to general discipline maintained in the college. Ninety-six per cent among the total respondents opined their very high gratification concerning teacher-student relationship. Inquiries based on level of individual attention given to students also prove to have their satisfaction at the highest level (views of 94 per cent respondents). Ninety-two per cent, among the total respondents of 200 also claimed their views based on the approach of administrative staff, found very noble.

The majority (88 per cent) opined that they are highly satisfied with the transparency in governance of the college. For the turn relating to wards exposure to adequate learning resources, the majority responds that they are highly satisfied (85per cent). Based on wards overall performance, most of the parents expressed their great satisfaction level, but meagre per cent (4 per cent) are of the assessment that they are only moderately satisfied. Rating of PTA & PTS also proves to be high satisfactory for the majority (86 per cent), however four per cent remarked it as simply acceptable.




Figure 2.8 **Rate PTA & PTS effectiveness** Satisfactory Poor 4% 0% Excellent 3% Good 10% Excellent ■ Very Good ■ Good Satisfactory Poor Very Good 83%

CONCLUSION

Analytical Report on Alumni Feedback

The Institution considers its alumni as a cherished source of information. Alumni feedback offers important viewpoints for assessing academic programs and student services. The feedback occupies a protruding position in the strategic progression policies. Statistical report based on alumni feedback regarding numerous standards has been discussed below.

I. GENERAL ASPECTS

For the analytical study, queries based on criteria such as, relevance of syllabus that contributed for their overall development, views on the initiatives put forward by the institution to improve their quality, infrastructure facility within, library and internet facility, faculty profile and all the more the rapport maintained with them by the institution was also asked.

Based on the clarifications received from the alumni it has been portrayed that, eighty-two per cent of respondents out of the total, 200 opined that they are highly satisfied with the relevance of syllabus that leads to their overall development. Considering the academics initiatives, taken by the institution to improve the calibre of students proves to be very good for eighty-two per cent of respondents, whereas two percent feels to be fabulous. Towards the introduction of grading system, the majority ninety-four per cent opined a very high-level satisfaction.

Interrogations respect to level of infrastructure proves to have high satisfactory for seventy-two per cent of respondents (144 people), at the same time, ten per cent is having their reservations. Survey based on library and internet facility proves to be very nice for fifty-seven per cent of defendants, whereas fourteen per cent shows their hesitations. Eighty-five per cent (170 alumni's) opined that, they are highly satisfied with the transparency in admission procedure, while three per cent marked it as exceptional.

Faculty profile in the college felt to be very much appreciative for the majority of respondents (86 per cent), but when the query of institutions adherence to the suggestions of alumni are asked, only less than the half (forty-three per cent) responded as they are highly satisfied, whereas twenty two percent expressed their doubts.

Only thirty-eight per cent expressed their views as they are highly satisfied with the institution's rapport with them, while twenty-four per cent had their own uncertainties. Queries relating to role of alumni in the overall development of the college proves to be highly satisfied only for thirty-one per cent of respondents, while twenty-four per cent remarked they are only moderately satisfied and ten per cent opined their experience as poor.

CONCLUSION

Succinctly, it is to be analysed that, in general, alumina's are of highly satisfied with the criteria's mentioned based on relevance of syllabus for their overall development, academics initiatives taken by the institution to improve the calibre of students, grading system, transparency in the admission procedure, and the faculty profile of the college, whereas they had expressed their hesitations regards to level of infrastructure facility, library and internet facility, Institutions adherence to the suggestions put forward by alumni, institutions rapport with alumni, and about the role of alumni in the overall development of the college, for that reason, the academy need to put more effort to enhance such efforts.

Analytical Report on Employers Feedback

Student Placements grasp a great importance for Educational Institutes. It may help a student in building a strong foundation for the professional career ahead, without facing the real-world job struggle, peer-competition or family pressure. A good appointment record gives a competitive edge to an Institution in the Educational Market. Student with a foot-in- the-door opportunity enables them to start off their career right after they have completed their course

curriculum. Furthermore, they get to interact and engage with the industry Professionals during the placement drives, which further help them to lay a foundation for their prospective career in the future as they disseminate with potential contacts from their chosen vocation field. Mostly it seems, Students are placed in IT Sectors, Banking, Teaching, Defence field etc., moreover when their Employer feedback is considered, it is the most determinant of the success of this prestigious Educational Institution. A well drafted questionnaire was set forth with queries based on syllabus and its transaction, and was asked to fill in by the employers.

Beginning the survey conducted for the academic year 18-19 based on several general aspects, it is been revealed form the table below that, eighty four per cent of the respondents (12 employers out of the total 14) are of the opinion that they are highly satisfied with the career orientation efforts exerted by the Institution for upgrading the student community whereas ten per cent comments to be good and only a meagre six per cent expressed their reservations.

Demands regards to the influence of curriculum leading towards the successfulness of students in meeting the social needs also proves to be very good for eighty one per cent of respondents whereas nine per cent expressed their misgivings. Enquiries based on promoting the skills of students for facing the competitive examinations proves to be respectable for seventy six per cent of respondents and only a meagre 4 per cent remarked their satisfaction as moderate.

Invoking critical thinking and reasoning proves to be really nice for twenty seven per cent of respondents and sixty eighty per cent feels to be good enough. While deciding about the relevance of curriculum in meeting the societal development more than the half per cent of respondents (52 per cent) marked as excellent, at the same time, curriculum relevance to meet the industrial needs was considered it is found to be fantastic for seventy eight per cent of respondents.

Inquiries based on promotion of team work and leadership with the aid of curriculum proves to be good for seventy eight per cent of defendants. Dealing with fostering culture of innovation proves to be satisfactory for the mainstream (sixty two per cent). Interrogation based on coping of curriculum with the new methods and technology proves to be fabulous for twenty four per cent of employers and virtuous for sixty nine per cent of employers whereas seven per cent found to be acceptable only.

In short, it is to be analysed that most of the proprietors are highly satisfied with the aspects of career orientation, successful in meeting the social needs, promoting skills for competitive examinations, creation of critical thinking & reasoning, for directing towards societal development, relevance to meet the industrial needs, in creation of team work and leadership & coping with new methods and technology, whereas the educational Coaching may give more emphasis on fostering the culture of innovation while laying down the design.

Analytical Report on Students Feedback

Feedback promotes personal and professional growth through positive criticism. Student's feedback was an attempt by the Institution to scrutinise the efficacy of curriculum design and the overall proficiency of the teaching learning process; moreover, the prime factor for the enhancement of the learning environment. Statistical report based on student's feedback pertaining to various criteria has been presented below.

Beginning the survey results for the academic year 2018-19, as shown in the table below, it is vibrant that eighty-four per cent (318 students) opined that they are exceedingly satisfied about the relevance of the course and syllabus offered. 246 out of 379 students (65per cent) responded that, the bridge course offered at the outset of every degree programme appears really nice; however, ten per cent commented the same as first-rate. Most of the students (85 per cent) speak out that the internal assessment procedures are of superb and five per cent of students commented that the assessment procedures are of excellent. Sixty-seven per cent (254 learners) are highly satisfied with the facilities provided by the career guidance and placement cell; whereas twenty per cent of students commented that the facilities provided are of respectable, on the other hand meagre per cent (thirteen) expressed their dissatisfaction.

All the more, from the learning it is vivacious that, majority of respondents are highly satisfied with the criteria's including relevance of course, syllabus and internal assessment, but highlighting needed to be exerted for conducting the bridge course and for elevating the events put forward by career guidance and placement cell.

II. TEACHING, LEARNING & EVALUATION

Assessment, the continuous process and the periodic exercise, helps in forming the values of judgement, educational status and for the achievement of the students. Proper evaluation plays a massive role in the teaching-learning process. The norms also deal with the efforts of an Institution to aid students of different backgrounds by the service of qualified and experienced faculty as per UGC Customs.

With the help of a well framed questionnaire, it is been evaluated and represented in the below mentioned table No:2, out of total 379 students, 89 per cent (337)students are of the outlook that, students centric approach in the teaching learning process are of really good, whereas 9 per cent expressed their judgment as worthy. Information and communication technology enabled methodology of teaching proves to be super for 60 per cent of respondents (227students), whereas 10 per cent found to be temperately satisfactory.

Enquiry based on redressal of student's grievances, concerning Cumulative Internal Evaluation exhibited the report as, 89 per cent of students disclosed their attitude as satisfied to a great extent, whereas 6 per cent of respondents felt the working of the cell to be Outstanding.

Research oriented activities are the key tool for gaining knowledge and making learning more reachable. Reports based on the ambience of Research activities in the college proves to be really nice for sixty one per cent of respondents, while 21 per cent responded that the ambiance within is of noble. Two per cent among the group found their stand to be poor.

Majority of the students (315) replied that, the collegeorganizes them opportunity to participate in the National and International Seminars, Workshops and Conferences and they commented the effort engaged as brilliant, however 15 per cent remarked as upright.

From the logical survey grounded on Teaching, Learning and evaluation facilities within the college, it is been evaluated that, the overall satisfactory

level of students centred on the above mentioned seems to be indebted, but One thing to be noted is that, Research ambiance within, needed to be amplified as meagre, 2 per cent of students had their hesitations.

III. INFRASTRUCTURE

As the students are now centring on the class rooms, labs, etc., while choosing a college, it's vital that academies have very good infrastructure in, with progressive laboratories.

Based on the survey conducted among 379 students, it is been revealed from the table below that, seventy-four per cent (280 students) are of the opinion that adequacy of classrooms and furniture availability are of very good, whereas 23 per cent comment it as good and three per cent responded to be fabulous.

Admittance to Proper sanitation facilities poses a massive upkeep to education as the lack of such facilities may lead to hygiene – related diseases. From the analysis it is clear that, seventy-four per cent responded that rest rooms are of sufficient in number and its maintenance are of really nice, whereas 26per cent of respondents observed that the rest room facilities are of righteous (depicted in table No: 3 below).

Majority of learners (Eighty two per cent) commented that labs are adequately equipped, with the expression that they are highly satisfied, while eighteen per cent of the respondents (68 students) expressed their view as moral. With regards to data collected concerning Library facilities, eighty-two per cent (311 students) reaction found to be wonderful, whereas 3 per cent feels that the library facilities are of admirable.

Most of the respondents (seventy four per cent) commented that the recreational facilities are of very good, at the same time six per cent are having their issues. Facilities provided for sports activities felt to be very nice only for forty three per cent of students; all at once forty two per cent expressed their hesitations.

Fifty one per cent of the students commented Canteen facilities to be very good, twenty seven per cent remarked as good and the rest twenty two per cent had their own misgivings. Survey with regards to extra-curricular activities found to be very nice for seventy six per cent of respondents and twenty one per cent out of the total respondents, 379 commented as upright.

From the diagnostic result based on Infrastructure facilities, it is been evaluated that the overall satisfactory level of students based on norms like classrooms, rest rooms, labs and library and amenities for extracurricular activities seems to be appreciative; however, the constant area which needed the advancement includes recreational facilities, sports activates and cafeteria facilities.

I. CURRICULUM DESIGN & DEVELOPMENT

The importance deals with how it is to be arranged to facilitate the learning. An Intense attempt has been made to discover its choice towards the value position.

From the review results depicted in the table below, it is evident that **the** majority (ninety four per cent) i.e., 54 teachers out of 57respondents are of the opinion that syllabus is suitable for the course and they expressed their opinion as they are highly satisfied, whereas four per cent having the feeling that it is of excellent, while considering whether the syllabi are of well-defined and clear, both to the students and teachers, eighty eight per cent responded to be very good.

From the questions based on, whether the course of studies carries sufficient number of optional papers, eighty six per cent of teachers commented their expression as great, while the influence of syllabi upon the creation of individual interest in the subject area proves to be very nice for eighty nine per cent of respondents (51 teachers). Based on inquiries in relation to appropriateness and updating of prescribed books and reference materials, it

found to be very good for ninety per cent of respondents (51 teachers) and two per cent marked their opinion as excellent.



II. TEACHING, LEARNING & EVALUATION

Educator's perspectives on learning has its prominence as it often emphasizes on curriculum content, academic achievement, sequencing, readiness and the importance of transferring learning to future positions.

By the help of a well framed opinion poll, it is been gauged that, highest satisfaction level from the majority of teaching faculty (82 per cent) can be witnessed in respect to the criteria based on freedom to adopt new strategies of teaching, whereas liberty to adopt innovative strategies of testing and assessment of students found to be very much impressive for eighty one per cent of respondents (46 teachers).

Survey based on the environment of the department, whether conducive to teaching and research proves to be very good for eighty nine per cent of respondents and eleven percentages felt it as good. Majority of the lecturers (ninety two per cent) expressed their satisfaction level as respectable, when queries based on availability of sufficient number of prescribed books in the library was questioned.







III. INFRASTRUCTURE

Infrastructure is the key base, for effective teaching-learning environment in academies. Education policy makers are increasingly focusing on the quality

of education and Institutional learning environments. Detailed analysis was made under various criteria to discover the truth. Table 3 below portrayed the actual picture that, eighty seven per cent of respondents (50 teachers) marked their response as very good in connection with the query based on adequacy of classrooms and furniture

Availability of teacher's room and toilet facilities proves to be very good for eighty eight per cent of respondents (50 tutors), whereas queries based on adequately equipped lab facilities proves that, eighty seven per cent have very high satisfaction at the same time, fewer per cent (3%) claimed the lab facilities to be excellent.

Information and communication technology facilities in the college proves to be very good for seventy one per cent of instructors, while ten per cent expressed that they are only moderately satisfied. Seventy five per cent of respondents expressed their views as very good in relation to internet and computer facility provided by the college, at the same time eleven per cent (6 of them) opined that they are only abstemiously satisfied.

From the above table it is obvious that, forty eight per cent of tutors found facilities provided for sports activities are of very good; however twenty nine per cent of respondents are only soberly satisfied with the facilities offered. Canteen facilities seem to be very good for more than half per cent of respondents (54 per cent), but twenty two per cent of teachers commented it that, they had an average satisfaction level.


